#### **COUNCIL MEETING**

New Richmond Village Council met in Council Chambers in regular session on Tuesday, January 12, 2016 at 7 pm. New Richmond Police Department Monthly Department Statistics for December of 2015 was handed out.

Mayor Carr opened the meeting with the Pledge of Allegiance.

#### **New Richmond School Board:**

Mayor Carr recognized Mr. Tim Dufau. Mr. Dufau was at council representing the school board. The school board will be sending a representative as needed.

## **Greg Roberts, Village Administrator:**

Ohio River National Freedom Corridor: This organization is working towards establishing a National Heritage Area in the Tri-State focused on the Underground Railroad. A very successful academic conference was hosted in October at Eastgate. Several officials with the National Park Service were in attendance. Subsequent meetings have been held in Cincinnati with representatives of the National Park Foundation, the National UGRR Freedom Center, NKU and others to develop a plan and proposal aimed at establishing the National Heritage Area. New Richmond figures to be a benefactor of the cooperative effort. Greg handed out a brochure and handouts about the New Richmond Underground Railroad Walking Tour. Greg also hopes to replace the green signs with something more attractive.

**Housing Revolving Loan Fund Administration Agreement:** The Ohio Development Services Agency is requesting a signed agreement as shown in the exhibit. Adoption of the attached resolution authorizing the mayor to sign is required. Resolution 2016-02: A resolution authorizing the Mayor to enter into a Housing Revolving Loan Fund

**Acceptance of Real Estate:** Representatives of Family Dollar stores have surveyed the former D&M Motel property on Old U.S. 52. They are cleaning up the lot lines which will result in the already *de facto* right of way property deeded officially to the Village. Per Council, an ordinance is the best way to accept the property. Legislation will be drafted when a legal description is provided. Mr. Vanderbosch questioned if a Family Dollar Store was the best use for the property on Old U.S. 52. Mr. Roberts stated that there is nothing in the Comprehensive Plan addressing the issue.

**Riverview Bluffs Bond:** We are requesting release of maintenance bond #B-0294528 to Freedom Homes for the storm water/detention basin and road surface course in the amount of \$21,855.00. Per Greg, the basin was last inspected in Oct. of 2014.

#### **Richard Hilt, Finance/Personnel Committee:**

**Fiscal Officer Lynn Baird:** Fiscal Officer Lynn Baird reported that the county has revised their estimate for the village's 2016 property tax revenue upward, which results in a revenue loss to the village somewhat less than the original estimate which should help considerably in budgeting for the future.

**Special Meetings with Department Heads:** There will be special meetings with department heads to discuss their budgets and any other questions about the 2016 Temporary Appropriations. These meetings are to be at 5:30 p.m. on January 13th with Fire/EMS, on the 20th with the Police Dept. and the 27th with General Fund

departments and Utilities. The first reading for 2016 Permanent Appropriations is on February 9th with final approval on March 8th

**Village Administrator Greg Roberts:** Greg recommended that council reduce the amount of flood insurance on the municipal buildings, which would reduce our premium from \$9,241.00 to \$4,382.00 which is a saving of \$4,859.00.

#### Mary Allen, Public Works/Parks/Recreation Committee:

**<u>2016 Public Works' Chairperson:</u>** Gary Skeene nominated Mary Allen to be the 2016 Public Works' Chairperson

**Cemetery:** Bill Marsh was not present at the meeting, but sent an email to members of the cemetery board with an attached draft of 2015 accomplished activities, seeking input from board members. Mary, Chair of Public Works, and Ramona Car, Mayor, were copied. His draft of 2015 activities is an attempt to partially satisfy the ORC Quarterly and Annual reporting requirements addressed in ORC 759.17. He has at least one next step, which is to meet with the Financial Officer regarding 2015 cemetery records. We need to understand if he needs something more specific from Public Works Committee. That was not clear in the email. If he does not need any specific action from

Public Works and if Greg, is aligned, We recommend Council support the documentation he's developed, related to cemetery management and it be properly recorded according to ORC guidelines. Bill gave us substantial information in preparation for us to be compliant.

**Flood Insurance:** Was noted in the Public Works minutes however because it was discussed in Personnel and Finance. Mary Allen is a member of the Personnel and Finance and Gary Skeene was sitting in the audience of that meeting, Amanda Davidson was absent. The two Public Works member present last night, were aware of all discussions related to Flood Insurance for Village Hall.

#### Sewer Infrastructure (Indian Ridge, Country Place, and Grays Lane/Robin Hill):

We've received acceptable bids for the discussed sewer expansion that were all under the engineers' original estimates. Interest rates for the loan from OWDA are now at .96% vs. the projected rate of 3.74%. Public Works supports Greg's proposal of moving forward with the loan application. Environmental Engineering is available to meet with us for any required discussion.

Linda West is retiring January 31, 2016 also with a number of years on the department. This opens a full time position as well as a Captains Position. She will really be missed. A full time member will be filled from inside applications.

Firefighter/Paramedic Sara Mitchell a new member Pay Per Call- needs to be approved. Also EMT Basic Natasha Simmons as Pay Per Call- needs to approved.
