COUNCIL MEETING

New Richmond Village Council met in Council Chambers in regular session on Tuesday, February 10, 2015 at 7 pm. Present: Richard Hilt, Richard Feldkamp; Gary Skeene, Amanda Davidson, Mary Allen and Paul Vanderbosch - members; Ramona Carr, Mayor; Donna Hammons, Clerk; and Greg Roberts, Village Administrator.

Mayor Carr opened the meeting with the Pledge of Allegiance.

Roll call was taken by the Clerk with Hilt, Feldkamp, Skeene, Davidson, Allen and Vanderbosch answering present.

David Neltner, Adams Recover Center:

Mr. Neltner was present at the invitation of Vanderbosch to review with council about the recovery center. He informed council that it is 'male only', an in-treatment facility which has a stay of 90 days. It is a 24 bed facility. They provide intensive out-patient services in Milford for 10 weeks after the 90 days is completed. Alcoholics Anonymous, Narcotics Anonymous and Smart Recovery are provided. All of the council members asked questions from 'what is the typical day like' to sprucing up the building to make it less utilitarian. Council thanked Neltner for coming to the meeting.

Mike Wylie, Administrative Assistant Police Chief:

Mr. Wylie briefly went over his work history with council. Mayor Carr explained this is a temporary need and the village will contract with Mr. Wyle at the rate of \$800 per week. He is contractual and thus not eligible for Police & Fire Pension or PERS Pension. He is not eligible for vacation time, sick leave, holiday pay or health insurance. Mayor Carr will be his immediate supervisor. The contract will run month-to-month until Police Chief Harvey returns to duty. Hilt motioned to suspend the three reading rule. Seconded by Feldkamp.

Greg Roberts, Village Administrator:

Presented a proposal from Public Entities Pool of Ohio (PEP) for property and liability insurance at a cost of \$37,451.00. Hilt motioned to approve. Seconded by Allen.

The new utility billing software implementation is near completion. We experienced some issues with transfer of data from the old system. Educating customers on the need to reduce costs will be a department focus. We are exploring less labor intensive meter reading options as future system cost reductions.

Roberts requested authorization to release Performance Bond #5010107 in the amount of \$29,149.00 to Grand Communities, Ltd. This is the final bond for the surface course paving of Block C, Section 1 of Regatta at Light's Hill Phase 1. Vanderbosch motioned to approve. Seconded by Skeene.

Richard Hilt, Finance/Personnel Committee:

Fire/EMS Chief Bee informed the committee that Police Officers Ken Frasure and Donnie Hahn received an Award for Excellence from Pierce Township trustees for their actions in a high risk incident at Hilltop Estates.

Roberts said he needs to purchase at least one new or lightly used pick-up truck this year. The replacement truck will be utilized by both the sewer department and the water department. He suggested we could finance this truck or purchase it outright, but need \$12,000.00 appropriated at this time.

Mayor Carr stated that she will meet with the county to discuss their latest estimates as to our revenue losses as a result of the closing of the Beckjord Power Plant.

The list of bills to pay has not been presented to council.

Mary Allen, Public Works/Parks/Recreation Committee:

There was not a meeting as there was no quorum.

Richard Feldkamp, Safety/Laws/Rules Committee:

Roberts discussed the current tree removal and that dead and dangerous trees are being removed only and that it is going well.

Roberts reported we have a good supply of road salt at this time.

The damaged guardrail at Dye Creek on Front Street was discussed. The camera is working well at the dump site and the problems there have almost stopped.

There was a discussion about ODOT re-paving U.S. 52 and the addition of crosswalks in the fall.

Chief Bee presented the resignation of Mable Sheppard, part-time Paramedic, and effective February 10, 2015. Feldkamp motioned to accept her resignation in good standing. Seconded by Allen.

Vanderbosch asked when repairs to the light across from RiverHills Bank will be made. Roberts answered he has been working on this situation. He has made numerous calls to and left messages to the manufacturer with no response. The contractor who installed the lights has also made calls with the same result.

Vanderbosch asked if council could have a quote for the same street lighting as the 100 and 200 blocks of Front Street for the 300 and 400 blocks. Roberts will get this information in an estimate figure as the 100 and 200 blocks of street lighting was financed with a grant and were installed not at the same time, but in different years.

Mayor Carr appointed Charlie Scott to the Board of Zoning Appeals - term ending 12/31/2019 and to the Housing Board of Appeals - term ending 12/31/2019.

Carr also reported the resignation of Doni Findlan from the Board of Zoning Appeals and from the Housing Board of Appeals. Carr appointed Mike Findlan to fill out the unexpired term of Doni Findlan ending 12/31/2016 for both boards.

Hilt invited Mr. Knapp to attend the Safety Committee meeting which is held the Monday before the first council meeting of each month. The committee meets at 3:30 pm here at Village Hall.
