COUNCIL MEETING

New Richmond Village Council met in Council Chambers in regular session on Tuesday, March 22nd 2016 at 7 pm. Present: Richard Feldkamp, Gary Skeene, Amanda Davidson, Mary Allen, Richard Hilt and Paul Vanderbosch - members; Ramona Carr, Mayor; Kelly Painter, Clerk; and Greg Roberts, Village Administrator.

Mayor Carr opened the meeting with the Pledge of Allegiance.

Ron Fletcher, Harley's Against Heroin:

Mr. Ron Fletcher came to council representing Harley's Against Heroin. The organization is interested in having an event in New Richmond. They are unable to get verification of insurance until 60 days prior to the event. The event will be a fundraiser with all proceeds going to Babies Born Addicted at Children's Hospital, Safe Harbor Hope, and Gateway House. The event will feature music and various vendors. At last year's event approximately 350 bikes participated. Harley's Against Heroin will be responsible for clean-up following the event. The event is planned to be held on July 30th, set-up will begin at approximately 7:00 a.m. with the event lasting from 1:30 p.m. - 10:00 p.m. Mr. Feldkamp suggested that they may be able to tag onto River Days insurance. Greg will walk the organization through the event application process.

Greg Roberts, Village Administrator:

Zoning Issues:

Letters are going out next week to rental property owners advising of the registration requirement. Inspections will commence in June. Over 300 rental units (apartments and single families) have been identified thus far. 222 Front Street has been issued a

violation letter for trash and reported to the county Board of Health. Greg handed out the letter that will be going out to rental property owners.

Sewer Expansion:

The loan application has been submitted to the OWDA. We should have a response and loan details available by the end of March. Payments on the loan would not commence until 2018.

WORKING SESSION:

Limiting working time:

Ms. Allen suggested limiting the time to end at 8:30 pm.

Possible Public Safety Levy:

Mr. Feldkamp suggested a Public Safety Levy to subsidize the cost of our safety and emergency services. 1 mill =approximately \$55,000. 7 mill = approximately \$385,000. It would increase property tax on a \$100,000 home would be approximately \$210 per year.

Possible 1/2% Income Tax Levy:

Mr. Skeene suggested a ½% Income Tax Levy.

Revenue Projections:

• Please note, this is additional revenue and the Village would not realize the total projected revenue until the 2nd or 3rd year of implementation.

Concerns Expressed:

Mayor Carr expressed her concern for retirees.

Ms. Allen would like to see the Public Safety Levy pass, however she would support either suggestion. Ms. Allen also stated that council needs to make a plan and be optimistic about the outcome. Ms. Allen also expressed concern the actual amount of earned income residents the village has and if it is enough to make a real difference.

CALL OF MEMBERS:

Vanderbosch - Nothing to report.

Allen - Nothing to report.

Davidson -Mrs. Davidson expressed concern about a series of water main breaks in Regatta. Greg stated that the latest break was not a main. It was a lateral feed into the main. Greg stated that the possible causes are either soil conditions or copper pipes are faulty. Greg suggested two options to deal with the breaks. Dig everything up and replace it (which would be very costly) or fix breaks as they occur. Mr. Feldkamp believes the water pressure has increased. Ms. Allen suggested investigating the cause of the increased pressure. Greg also expressed concern about fixing taps located under the apron of driveways in the village subdivisions. Mayor Carr suggested contacting Fischer Homes. Greg also expressed concern about meters not being located in the village right of way.
