### **April 28, 2015**

#### **COUNCIL MEETING**

New Richmond Village Council met in Council Chambers in regular session on Tuesday, April 28, 2015 at 7 pm. Mayor Carr opened the meeting with the Pledge of Allegiance.

**Zachary Walton and Adam Nassar - New Richmond High School Government Class -** They were present to ask council to redo the basketball court at Plum Street Park. One of the backboards does not have a hoop and the blacktop needs repaved. They figure it may cost around \$2,500. Mayor Carr advised them to talk with Greg Roberts, Administrator. Roberts said he will meet with them at the basketball court tomorrow afternoon.

## **Greg Roberts, Administrator:**

Recommendation on streets to be paved in 2015 will be submitted for review at the next Public Works committee meeting. Several streets are dire need of patching. Feldkamp suggested the village put a nice patch of blacktop on Short Hill Road while the pavers are in town.

The grant application for rehab of well #3 was submitted to the county. We did not receive funding. The county scoring system favored applicants that had not received funding in the past 3 years. Vanderbosch asked what will happen if well #1 and well #2 are not functional. Roberts said we have a connection to Tate-Monroe water system. Allen suggested we try out this connection at least once to be sure it works.

The roof project on the sewer plant is complete. Painting is out for additional bids.

Roberts has started a different approach to U.S. 52 right-of-way mowing. We will be looking to trim back some of the overgrowth of brush along the fence row.

Hilt asked when the felled trees will be removed. Roberts replied very soon. The area where we dump the trees had been under water and needs to dry out. Allen asked that trees be removed from residential areas first.

#### Randy Harvey, Police Chief:

Reported that Les Smith as voluntarily removed himself as Sergeant back to Patrolman effective April 23, 2015. Vanderbosch motioned to approve. Seconded by Feldkamp.
